TERMS FOR APPROVED DEALERS

DOMESTIC SHIPPING: We ship ONLY with UPS, no exceptions. Ground shipping is our standard method of shipping unless otherwise specified. Next Day Air, 2nd Day Air, and 3 Day shipping options available at extra charge, please specify. COD shipping available but includes a handling fee. All shipping charges based on package weight and dimension.

INTERNATIONAL SHIPPING: Holz Racing Products offers two shipping options for our Canadian customers:

OPTION #1: UPS Standard / Expedited / Express. We will ship your individual order via UPS for the next immediate pick-up. You will be charge freight, tax and brokerage accordingly for your individual shipment.

OPTION#2: Consolidated shipping via Purolator. With our consolidated shipping program once every week we ship a consolidated order via Purolator using our own broker. Holz Racing Products will bill you directly for all shipping, tax and brokerage charges. You will receive your order without any additional charges. Our consolidated shipping program is designed to reduce shipping and brokerage costs by dividing the single brokerage and shipping charge amongst all orders within the one consolidated shipment.

NOTE: Consolidated shipping is once a week. This may not be the preferred method for "rush" orders.

DROP-SHIP ORDERS: WE WILL NOT DROP SHIP ORDERS. No Exceptions!

PLACING ORDERS: All dealer orders must be place via phone or fax as we do not yet have a dealer log-in on our web site. Orders must be pre-paid before they are shipped.

PAYMENT: We accept Visa, Mastercard, AMEX and Discover. We do not save or keep credit card numbers on file. COD shipping is available to lower 48 states but also includes an additional handling fee. Net-30 terms is available only for an 'established' dealer and can be arranged at our own discretion.

PRICING: All authorized dealers for Holz Racing Products will be given the same discount/price level-Volume pricing available for bulk orders, please inquire. All prices are subject to change at any time. We insist that any 'advertised' prices must be our suggested retail. Retail and dealer prices do not reflect any freight or tax where applicable and will be added. Any advertised 'sale' prices by Holz Racing Products reflect only our own inventory on hand and may not affect dealer pricing. All prices subject to change and are not retroactive.

WEB SITES / ON-LINE STORES: Dealers that wish to display the Holz logo or brand must receive written permission before doing so. Link exchange is available upon approval. Selling Holz brand parts and accessories is allowed only if the suggested retail pricing and the Holz brand name is displayed. Product photos are available upon request. All authorized dealers that maintain a web site/web store where Holz Racing Products are sold must meet all requirements as listed at the top of the dealer application - specifically you must already own/lease and operate a legitimate retail store front.

If at any time we feel that our company livelihood and/or reputation has been undermined by the use of our name, brand, photos or anything else relating to Holz Racing Products, your dealer status will be terminated immediately. Dealer status will not be renewable and no returns will be accepted and product warranties will not be honored.
